- Participating in international travel during the four months prior to the start of my program has the potential to prevent me from obtaining my required visa and is strongly discouraged due to the lengthy nature of the Icelandic visa process which may take right up to 90 days to process.
- ☐ I understand that my enrollment will be withdrawn and I will not be allowed to participate in the program if I have not obtained the required visa prior to arriving on the program.

For non-US passport holders, I knowledge that:

- It is my responsibility to make myself aware of the requirements pertaining to traveling on a non-US passport. Students traveling on a non-US passport may be subject to different or additional requirements and/or fees for obtaining a visa or meeting other conditions of entry into the country during your program. I will contact the embassy of the country shortly after being offered admissions to the program to confirm visa and/or entry requirements applicable to my country of citizenship and determine next steps while allowing plenty of time to apply.
