- □ The Indonesian consulates may change visa requirements and fees at any time. Before beginning the visa application process, I must verify the most current requirements and fees through the consulate's website.

- ☐ I understand that SIT has no affiliation with the Consulate of Indonesia.
- □ I have read and understand the pre-visa instructions, and I will submit my materials to SIT by the deadlines communicated to me by my Admissions Counselor.
- Students without a US passport may be subject to additional or different requirements for obtaining a visa or meeting other conditions of entry into the country or countries listed above. Many countries require individuals to apply for visas in person at the relevant embassy or consulate located in their country of citizenship. We strongly recommend that you contact the embassy of each country the program will be traveling to very early in the process to confirmation visa and/or entry requirements applicable to your country of citizenship and determine next steps while allowing plenty of time to apply.
