

## Visa Acknowledgement Form

Due to the number of visas for which you will be applying and the complicated nature of the application process for these visas, SIT asks you to return this form acknowledging your understanding of the following information. SIT will send you visa application instructions during the three months preceding your departure for your program. It can take anywhere from several days to several weeks for a single consulate to process your visa application. Processing time and required materials will vary from country to country and consulate to consulate so it is important to begin as soon as possible to avoid delay. Please review the following points and provide all the requested information so that our office may begin preparing your visa documents.

## FOR NON-US PASSPORT HOLDERS, I KNOWLEDGE THAT:

It is my responsibility to make myself aware of the requirements pertaining to traveling on a non-US passport. Students traveling on a non-US passport may be subject to different or additional requirements and/or fees for obtaining a visa or meeting other conditions of entry into the countries visited during your program. I will contact the embassy of each country the program will be traveling shortly after being offered admissions to the program to confirm visa and/or entry requirements applicable to my country of citizenship and determine next steps while allowing plenty of time to apply.
☐ I am responsible for making sure I obtain a transit visa for any of the countries that the program has layovers in.
☐ Non-US passport holders requiring supplemental supporting documents are responsible for notifying their admissions counselor of those needs in a timely fashion.
Many countries require individuals to apply for visas in person at the relevant embassy or consulate located in their country of citizenship, though not always.
☐ If the foreign consulate(s) permits non-US passport holders to apply for the required visa from within the United States, applicants are encouraged to contact Travisa Visa Services. As an experienced visa agent working closely with a number of SIT programs, Travisa may be able to assist you in your visa application process.
☐ It is your responsibility to confirm and complete the visa application process particular to your situation, and to keep your admissions counselor informed.
